RESOLUTION NO. 94-07

ACCEPTANCE OF DESIGNATION AS SERVICE AUTHORITY
FOR FREEWAY EMERGENCIES (SAFE) FOR MENDOCINO COUNTY

THE MENDOCINO COUNCIL OF GOVERNMENTS HEREBY FINDS, DECLARES,
AND RESOLVES THAT:

WHEREAS, call boxes have demonstrated throughout California,
that they are effective in increasing emergency response time and
overall safety situations; and

WHEREAS, Mendocino County concurs with the concept of call
boxes on our rural highways and has demonstrated that support
through adopted resolutions authorizing the formation of a Service
Authority for Freeway Emergencies (SAFE) for Mendocino County by
the Board of Supervisors of Mendocino County and the City Councils
of the City of Ukiah, Fort Bragg and Point Arena; and

WHEREAS, the Board of Supervisors of Mendocino County and the
City Councils of the City of Ukiah, Fort Bragg and Point Arena have
adopted a Resolution authorizing the formation of a Service
Authority for Freeway Emergencies (SAFE) for Mendocino County; and

WHEREAS, the Mendocino Council of Governments is the Regional
Transportation Planning Agency for Mendocino County; and

WHEREAS, the Mendocino Council of Governments is comprised of
two members of the Board of Supervisors, one County appointed
elected official, one representative from City Council of the
Cities of Ukiah, Willits, Fort Bragg and Point Arena; and

WHEREAS, each entity has designated the Mendocino Council of
Governments as the SAFE for Mendocino County in accordance with
Streets and Highways Code Section 2551; and

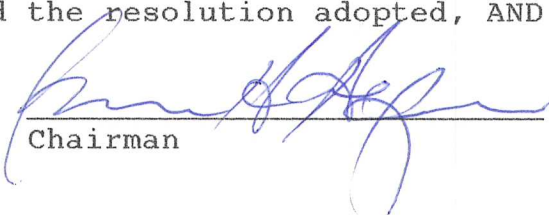
WHEREAS, the Mendocino Council of Governments is willing to
accept the responsibilities of a SAFE as set forth in the Streets
and Highways Code;

NOW, THEREFORE BE IT RESOLVED THAT: The Mendocino Council of
Governments hereby accepts its designation as the Service Authority
for Freeway Emergencies in Mendocino County, and agrees to carry
out the responsibilities of a SAFE.
