INTRODUCTION

In support of ChargePoint's grant application to the California Energy Commission (CEC), in March, 2022, the Mendocino Council of Governments (MCOG) sent a "Letter of Commitment" to the CEC committing to partner with ChargePoint to seek community input and determine the best locations for the installation of publicly accessible, rural electric vehicle (REV) charging infrastructure, to serve local communities' needs.

ChargePoint's CEC grant application was successful, and a project was awarded to install a total of 25 rural electric vehicle chargers at five separate sites in the greater Ukiah area. The project is envisioned to include a fast charging hub in central Ukiah, plus four additional sites to be located in the greater Ukiah area (Redwood Valley – Ukiah – Hopland). Each of the five sites are expected to include approximately five chargers.

PROJECT TIMELINE

MCOG staff met with ChargePoint staff in late 2022 to begin planning for a community and stakeholder outreach process in early 2023, with the following timeline:

- December 2022 January 2023 develop and advertise outreach materials and events
- February 15, 2023 launch outreach process with online community survey/map tool
- February 16, 2023 hold virtual Community Workshop
- February 22, 2023 hold virtual Stakeholder Workshop
- March 15, 2023 Close online survey/map
- April 14, 2023 Submit Community Outreach Summary Report to ChargePoint

OUTREACH & ADVERTISING

MCOG conducted a thorough public outreach process, using a variety of methods, to solicit community and stakeholder input on where the new charging stations should be located in the greater Ukiah area (Redwood Valley – Ukiah – Hopland).

An extensive stakeholder and community email contact list was used to send workshop announcements and on-line survey announcements to community contacts, community based organizations, nonprofits, advisory boards, local governmental staff, and all ten Native American Tribes in Mendocino County. Efforts to reach disadvantaged and low-income communities were made by advertising the workshops and survey in English and Spanish in local media and through sending emails to local agencies that serve the disadvantaged community, and posting numerous informational flyers throughout the community.

- January 30 & 31, 2023 email invitation (in English & Spanish) sent to extensive mailing list announcing virtual Community workshop and alternate ways to provide input
- January 31, 2023 announcement with Zoom meeting information for Community workshop and Stakeholder workshop posted on MCOG's website, and email sent to website subscribers
- January 31, 2023 email invitation sent to Stakeholder mailing list announcing virtual Community and Stakeholder workshops, survey, and alternate ways to provide input



Virtual Community Workshop – held February 16, 2023

On February 16, 2023, representatives from MCOG and ChargePoint held a virtual Community Workshop (*via Zoom*) to present information to community members on ChargePoint's California Energy Commission (CEC) grant to install 25 new EV charging stations in the greater Ukiah area (Redwood Valley – Ukiah - Hopland), and to invite public input. Attendees were invited to comment on where the stations should be located, and to take the online survey. Information on alternate methods of how to submit written comments (via U.S. mail and e-mail) was also provided.

The workshop was widely advertised by MCOGC through email contacts, press releases, social media postings, and on MCOG's website. Efforts to reach disadvantaged and low-income communities were made by advertising the workshop in local media and through sending emails to local agencies that serve the disadvantaged community, as well as to all ten local Tribes.

Attendance for the community workshop included approximately 14 attendees, five of which were MCOG and ChargePoint representatives.

Virtual Stakeholder Workshop – held February 22, 2023

On February 22, 2023, representatives from MCOG and ChargePoint held a virtual Stakeholder Workshop (*via Zoom*) to specifically hear from local stakeholders on where 25 new EV charging stations (funded by CEC grant) should be installed, in the greater Ukiah area (Redwood Valley – Ukiah – Hopland). Attendees were invited to comment on where the stations should be located, and to take the online survey. Information on alternate methods of how to submit written comments (via U.S. mail and e-mail) was also provided.

Attendance at the stakeholder workshop included approximately 11 attendees, five of which were MCOG and ChargePoint representatives, and five of which were representatives from the County of Mendocino. There was also one representative from Caltrans.

Suggested locations and comments are summarized below:

- Install chargers for local commuters for those who don't have charging stations at home, including renters. Also, at grocery stores, Costco, Walmart.
- The County received a separate grant for chargers at the County Administration Center on Low Gap Road, and at the Yokayo/Social Services Building, Ukiah. The Low Gap site is near ball fields and schools, and the Yokayo site is near the Co-op and other public use facilities. The idea is to have chargers publicly available during off hours when people are not at the Admin center, with County vehicles charging in the evening hours.
- County representatives expressed a desire to coordinate with ChargePoint on co-locating chargers. ChargePoint representative will need to look at list of other properties County provided, and will check on grant requirements and follow up with County staff.
- Maintenance of chargers, and warranty issues, were discussed. If chargers are placed on County property but County is not the owner/operator, a site agreement lease would need to be negotiated. If County is owner/operator, County may set policies to offset initial investment and pay utility bills. County would need to do analysis on the return of investment.
- County will be looking at future locations in Redwood Valley, Willits (*possibly at Library*), Fort Bragg, Point Arena, and eventually Covelo, coast, and north county. County is interested in partnering with ChargePoint on future locations.
